## 1. Short biography of the candidate

The onl\ candidate in the competition Chief Assistant Doctor Stefan Atanasov Raychev - was born in 1484. He graduated in 2009 with a degree in "Human Resources Management" from Plox dix University (PTJ) "Paisii Hilendarski". In 2016. Stefan Atanasov Raichev was awarded the educational and scientific degree "Doctor" at Plovdiv Uni versit} "Paisii Hilendarski".

Since October 2017, Doctor Stefan Atanasov Raychev has been working at Plovdiv University "Paisii Hilendarski" as a Chief Assistant in Political Economy -• Public Sector Economics. As such, he reads lectures and exercises on: Labor Economics; Economics of the Public Sector; Economics.

# 11. General characteristics of the scientific and applied work of the candidate

1. Genered description of the submitted materials (monographs, textbooks, articles, reports, projects, etc.) by research fields

For his participation in the competition. Chief Assistant Doctor Stefan Atanasov Raychex presented 18 (eighteen) publications in a lota! volume of 781 standard pages, including individual research and collective works.

The publications of Chief Assistant Doctor Stefan Atanasov Ravchev are grouped as follows:

- 1. Habilitation work (equivalent publication) two parts of a collective monograph (part two and part three), with author's text in a volume of 2 16 standard pages.
- 2. Published monographs that are not presented as a main habilitation thesis (equivalent publication) I item with author's text in a volume of 214 standard pages.
- 3. Book published on the basis of a defended dissertation for the award of educational and scientific degree "Doctor" 1 item with author's text in a volume of 143 standard pages.
- 4. Articles and reports published in non-referenced scientific peer-reviewed journals or in edited collective volumes 12 items, of which 4 independent reports at international scientific conferences with author's text in volume, respective!} of 5, 6. 8 and 4 standard pages, and 8 collective publications with author's text 1-3 of a tola! of 105 standard pages.
- 5. Studies published in scientific journals, referenced and indexed in world-known databases of scientific information (SCOPUS and Web of Science) I studies in co-authorship in volume of 28 standard pages, the volume and scientific contributions of the three authors being distributed evenl}.
- 6. Published chapter of collective monograph 1 chapter with author's text in volume of 1/3 of 39 standard pages.
- 7. Published university textbook in a collective Stoyanova. D., Raychev. S. (2018). Handbook of Economics. I University- Publishing House "Paisii Hilendarski". Plovdiv. ISBN 978-619-202-3737. with

authorship in the volume of 155 pages (topics I -1 0).

Of the 18 publications of Chief Assistant Doctor Stefan Atanasov Raychev submitted for participation in the competition. 6 publications are in English (one study in co-authorship, reports at international conferences and online magazines).

The presented publications of Chief Assistant Doctor Stefan Atanasov Raychev for participation in the competition are not used for obtaining the educational and scientific degree "Doctor".

## 2 General characteristics of the candidate's scientific, applied and teaching activities

The scientific activity of the candidate Chief Assistant Doctor Stefan Atanasov Raychev is satisfactory. presented by individual and collective publications such as a monograph, chapters from collective monographs, study, reports, textbook.

As a content, the presented publications reflect the consistent scientific orientation of the author towards quantitative measurements and analyses of parameters, relations and interactions on the labor market, in the field of education and at the standard of living. This is also the main field in which the candidate's scientific activity' is realized with the main emphasis - application of various methods and tools for assessment of dy namics and interactions between main parameters in the field of labor, education and living standard and their comparison on a national and regional scale.

T he scientific and applied activity of Chief Assistant Doctor Stefan Atanasov Raychev is active and is represented by participations in 10 scientific projects implemented within the Research Fund of the Plovdiv University and projects funded by OPHRD. cross-border cooperation programs INTERREG. national program "Young scientists and postdoctorants 2019", Research Fund at the Ministry of Education and Science, etc. In some of these projects he is an expert from the research team, in others he is an academic mentor, he has also been the head on scheme "Qualification services and training of employees" under OPHRD.

The leaching activity of Chief Assistant Doctor Stefan Atanasov Raychev relates to training of students m PU as an assistant in Economics (I abor Economics. Human Resources Management. 1 abor Market Policies. Economics. Globalization and Social Policies) and as a Chief Assistant in I.abor Economics. Public Sector Economics and Economics.

#### III. Quantitative characteristics of the candidate's scientific work

The quantitative characteristics of the scientific work of the candidate Chief Assistant Doctor Stefan Atanasov Raychev meet the minimum science-metric requirements for the academic position "Associate Professor", according to the Eaw on Development of Academic Staff in Bulgaria, the Regulations for its implementation and the Regulations of PU.

#### IV. Evaluation of the results and scientific contribution of the candidate

#### 1. Scientific achievements of the candidate

The scientific contributions of the candidate Chief Assistant Doctor Stefan Atanasov Raychev can be characterized as enrichment of existing knowledge by diversifying the instruments for studying mam parameters of the economic and social area, search for quantitative changes and measuring interactions anti dependencies between indicators of labor market, education and living standard: analyzing ihe assessed interactions in a comparative plan and formulating conclusions about the convergence processes in the European Union and **at national and regional level.** The author uses the **conclusions from the assessments** of trends, interactions and dependencies to make assessments of implemented polieies and to ground recommendations for improving the policies in the field of the labor market, education and poverty reduction in the country.

I evaluate the most significant scientific contributions of C hief Assistant Doctor Stefan Atanasov Raychev, which are contained in the scientific publications presented in the competition, in several directions:

- Measuring the dynamics. the changes in the structures and interrelations of main parameters on the labor market, in the field of education and standard of living for comparative evaluations of the degree of integration between Bulgaria and the EU, between the regions in Bulgaria, in the Western Balkans region (Stoyanova, D., Raychev, S., Madzhurova, B. (2019). Social cohesion (National, regional and structural dimensions in the context of Bulgaria EU Western Balkans; Raychev. S., Madzhurova, B., Stoyanova, D. (2020). Impact of globalization on the nature of jobsand employment; Stoyanova, D., Madzhurova. B., Raychev, S. (2019). Cohesion in the Held of education level reached in Bulgaria, the EU and the Western Balkans. European integration today some problems and opportunities; Ray chev. S. (2020). Effects of Public Policies on the Labor Market for Stimulating Economic Growth and Reducing Inequality: Raychev, S. (2015). trends in labor market prod net i v ily and wage disparities; Raychev, S. (2015). Research of inactive young poptilation and youth labor market policies in Bulgaria).
- Construction of a model for complex assessment, including different types of techniques (analyses graphical, descriptive, correlation, rank: correlation matrices and regressions), which study the dynamics and structural changes in key indicators: on the labor market (employment, unemployment rate, long-term unemployment, economic activity: inactive youth population); in the field of education rate of early school leavers and those outside the field of education and outside the labor market (so-called NEE'I S): in the field of standard of living risk of poverty, of persons living in households with low intensity of economic activity, of the share of the population living in material deprivation.
- Evaluation of the interactions between general and long-term unemployment, employment and economic activity in the period 2008-2016 have been made using correlation-regression matrices (2019. Social cohesion, chapter 2: 2019, European integration today some problems and opportunities): between the dy namics of labor productivity and wage disparities (2015, Trends in labor market productivity and wage disparities).
- Based on a generalizing rank analysis, conclusions are formulated for increasing the distance between Bulgaria and the EU. as the main factors are identified the level of economic activity, early school leavers, as w ell as the parameters of those living at risk of poverty and households with low iniensity of economic activity (2019. Social cohesion.... p. 159). These conclusions draw attention to public policies and their contribution to Bulgaria's convergence with the EU (2U19. social cohesion.... p. 163).
- Studies oi the changes in the studied indicators and other profiles (gender, age, education) are made, analyzed through the prism of the structural changes in the economy; The generalized rank analy sis at structural level highlights slow convergence rates for most of the studied profiles (2019, Social cohesion..., p. 255-261).
- To assess the impact of globalization on the nature of the jobs and the sectoral changes in the economy at the national level, studied are the changes in the work patterns (full-time and parttime) and the impact of independent variables such as R&D expenditure, lifelong learning, government balance and export (Raychev, S,, Madzhurova, B,, Stoyanova, D. (2020). Impact of globalization on the nature of jobs and employ ment. chapter 2 and 3).
- 1 he described changes in the dy namics and structure of employ ment in comparison show the presence ol statistically significant correlations between the studied macroeconomic parameters and the employment, based on which conclusions are made to reduce the direct participation of the stale in the new global changes at sectoral level and its focus on regulations and policies for balanced development of' employ mein and standard of' living in these conditions (Impact of globalization on the nature ofjolw and employ rnenl. ., p. 265).
- 1 he economic efficiency of the public investments is evaluated in comparative terms; of the -amilariiies and differences between the countries concerning the investments in public policies on the labor market and the assessments of the effects of the public policies on the labor market on growth and inequality in El; Member States (Raychev. S. (2019). Effects of Public Policies on the Labor Market for Stimulating Economic Growth and Reducing Inequality).

- 1 he in-depth analysis of the nature and evolution of the scientific thinking about the role of the free market and the stale intervention, the opportunities to influence economic growth and reduce income inequality through public policies on the labor market, enrich the available knowledge on the possibilities through a balanced government intervention on the labor market with public policies on employment to stimulate growth and help reduce income inequality (ibid.).
- A critical review of different models for evaluation of the public policies in the field of labor market (2015, Evaluation of public sector efficiency, collection of reports, PU) is made with conclusions about opportunities to increase the effectiveness of the latter in the application of the appropriate evaluation instruments.
- 1 he impact of the technological progress and the investment activity on the labor market in the period ?.(H)o-2018 in Bulgaria and the EL is assessed. I racing the relation between structural changes in employment by sectors and R&D expenditures outlines the conclusions that running technological changes and structural product restructurings accelerate the closure of traditional jobs, stimulate the creation of new ones with different requirements for the competencies and professional -Tills of the employees (Raychev. S. Stoyanova. D.. Madzhurova B. (2020). The impact th'innovation and technological progress on the labor market, shared co-authorship).
- 1 he study of the social entrepreneurship as part of the integration processes, of lifelong learning as the main lever for maintaining the quality of the labor force in the conditions of dynamic technological changes expand the scope of the author's research in search of rational suggestions for balanced and stable social development (reports at international conference, 2020, Economic and social integration, PU, co-authored).

# 2 (ore/v/ge oj the scientific publications of the candidate in our and foreign literature

fhe scientific publications of Chief' Assistant Doctor Stelan Atanasov Raychev are covered in the national and international literature through 6 citations, 2 of them in referenced and indexed databases, and 4 - in non-refereed journals with scientific review.

#### 5. Significance of the contributions to science and practice

fhe contributions in the works of Chief Assistant Doctor Stefan Atanasov Raychev have their scientific significance mainly through the development and application of a rich instruments for measuring and comparing the trends and structural changes in indicators from main socio-economic areas (labor market, education and standard of living). In practical terms, the contributing points are the evaluations and re-evaluations of acting policies in the mentioned three areas.

# KAssessment of the originality of the presented works and the reliability of the presented scientific data

The scientific works submitted by Chief Assistant Doctor Stefan Atanasov Raychev for participation in the competition for academic position "Associate Professor", in my opinion, are his personal works and do not contain plagiarism.

## J 7. Critical notes and recommendations

My critical notes on the works presented by Chief Assistant Doctor Stefan Atanasov Raychev have the character ol' recommendations and they arc oicontenl and formal nature.

The recommendations of a content nature aim to deep the analytical part of the obtained results and to reveal those specific interactions and factors that determine the quantitative changes in the studied indicators, as well as the specific variables forming the regional and national specifics of the socioeconomic development.

The formal recommendations aim at more precision in the preparation and presentation of the documents for the competition in terms of the author's participation in the collective works, the arrangement of the publications, the presentation of the citations, etc.

I would recommend the author to keep his activity for participations in scientific forums, but also to focus on independent scientific publications in scientific journals in the country and abroad.
