1. General presentation of the received materials

By order № P33-4125 of 24.08.2020 of the Rector of the University of Plovdiv "Paisii Hilendarski" (PU) I was appointed a member of the scientific jury of a competition for the academic position of 'associate professor' in PU in the field of higher education 4. Natural sciences, mathematics and informatics, professional field 4.1 Physical sciences (Electrical, magnetic and optical properties of condensed matter), announced for the needs of the Department of Physics at the Faculty of Physics and Technology.

Only one candidate has submitted documents for participation in the announced competition: Ch. Assistant Professor Dr. Ivan Panayotov Bodurov from the Department of Physics, Faculty of Physics and Technology, University of Plovdiv.

The set of paper materials presented by Dr. Ivan Panayotov Bodurov is in accordance with the Regulations for development of the academic staff of the University of Plovdiv, and includes the following documents:

- diploma for educational qualification degree 'master' in the specialty Physics of condensed matter;
- diploma for educational qualification degree 'master' in the specialty Teacher of Physics;

- reference for observance of the specific requirements of the respective faculty, in accordance with Article 65. (3) PRASPU;
- annotations of the materials under art. 65. from PRASPU, including self-assessment of contributions;

The candidate Dr. Ivan Panayotov Bodurov has submitted a total of 43 scientific publications in referenced scientific journals, which are not included in the scientific publications for obtaining the educational and scientific degree "Doctor". The submitted materials for participation in the competition for the academic position of "Associate Professor" include 1 textbook, 1 manual for laboratory exercises and 3 useful models, which are the result of the scientific activity of the candidate after holding the academic position of "Chief Assistant".

43 scientific papers are accepted for review, which are outside the dissertation and are considered in the final evaluation: 1 textbook, 1 manual for laboratory exercises and 3 useful models. The distribution of scientific papers by relevant sections, in the country and abroad, is as follows:

- 5. The submitted materials for participation in the competition for the academic position "Associate Professor" include 1 textbook, 1 manual for laboratory exercises and 3 useful models, which are the result of the scientific activity of the candidate after holding the academic position "Chief Assistant".

3.3. 7 graduates from Plovdiv University "Paisii Hilendarski" were led and successfully defended.

4. The scientific and scientific-applied activity of the candidate is significant:

- Participation in 14 research projects;
- 3 useful models have been developed;
- 42 scientific publications have been written in referenced scientific journals, which are not included in the scientific publications for obtaining the educational and scientific degree "Doctor".
- There are 45 citations (without self-citations), most of them in journals with impact factor

The candidate fulfills all the recommended requirements of the University of Plovdiv to hold the academic position of "Associate Professor" in the professional field of Physical Sciences. There is also a chapter published in a book.

5. Critical remarks and recommendations

My recommendation to the candidate is in the future to have independent scientific publications and / or other scientific developments (patent, utility model or other applied development).
