The monograph "Social protection in case of unemployment /Social work with unemployed persons/ presents the author's concept of social protection in case of unemployment as a complete system, including the subsystems of social security in case of unemployment, social assistance to unemployed persons and active policies of the labor market to promote employment . A special emphasis in the development is the presentation of the theoretical-methodological aspects of social work with unemployed persons, considered in the aspect of a sequence of social activities carried out in the subsystems of social protection in case of unemployment.

The monograph contains *six parts*, and their structure follows the logical sequence of the elements of the unemployment protection system, determined



according to the author's view of its content. In the individual parts, the issues under consideration are systematized in chapters.

The content of *the first part* forms the theoretical framework of the concept of social protection in case of unemployment. The definition of the essential characteristics of social protection is based on a theoretical analysis of existing definitions, considering the main challenges to its development. On this basis, the author's view of the social protection system and the relationship with its basic elements - social security, social assistance and interventions on the labor market was formed. The economic and social dimensions of unemployment are indicated, with special attention being paid to an analysis of

the main trends in its development for the period 2004-2021. The conceptual position

on the content of social protection in case of unemployment and its essential characteristics such as the unity of subsystems of social security in case of unemployment, social assistance to unemployed persons and active policies to promote their employment are presented.

The second part examines unemployment social insurance as the main element of unemployment protection. Theoretical and methodological aspects of unemployment such as insurance risk and the legal regulation of unemployment insurance are presented. Emphasis is placed on cash benefits in case of unemployment based on a theoretical study of the characteristics and functions, which is supplemented by an analysis of the specific situations related to their legal regulation in relation to their specific parameters. The dynamics of unemployment benefits for the period 2004-2021 have been analyzed. on the basis of general indicators and indicators representing the structure of unemployed persons receiving benefits. Special attention is paid to the additional voluntary unemployment insurance and professional qualification.

As the next element of social protection in case of unemployment, *the third part* of the monograph presents the problems related to the social support of the unemployed. The social benefits paid, as well as the possible services that can be provided to unemployed persons, are examined.

In *the fourth part* of the monograph, active measures on the labor market are presented as a third element of the unemployment protection system, supplementing the effect of the action of the previous two components. The main priorities of the national employment strategies, as well as the content of individual target programs, are systematized in separate applications.

The fifth part examines the potential of alternative forms of employment as an opportunity to limit unemployment with a special emphasis on social entrepreneurship and social enterprises, centers for sheltered employment and centers for employment and social assistance.

The functioning of the unemployment protection system is related to the practical implementation of social work with unemployed persons as one of the subsystems of social work, which is the subject of consideration in *the sixth part* of the monograph. Social work with unemployed persons is presented as a sequence of social activities carried out in individual subsystems. The functions within the scope of social activities in unemployment social insurance, social assistance for the unemployed and active measures on the labor market are examined in detail.

The main conclusions of the theoretical overviews and the specific analyzes considered in the separate parts of the monograph are formulated. The theoreticalmethodological part, related to the presentation of existing studies on the issues under consideration in each part of the monograph, is complemented by a study of the relevant legislation and specific analyzes of the dynamics of the processes characteristic of each of the subsystems of social protection in case of unemployment.

The purpose of the research is to define the main trends in unemployment insurance in Bulgaria with an emphasis on the cash benefits paid in the conditions of the serious challenges that the Covid-19 pandemic has created for the functioning of the national labor market and to assess their compliance with the realization of the functions of unemployment insurance as an element of the social protection system.

The generalization of the trends in the dynamics of supplementary pension insurance is aimed at proving the thesis about the ability of pension insurance companies to realize the legally regulated obligation to pay supplementary pensions from the second pillar.







The textbook is divided **into two parts.** The first part of the textbook presents basic theoretical positions of the pension insurance system in the aspect of a basic element of social insurance and the development of the pension insurance system in Bulgaria.

Section one of the textbook examines the basic theoretical aspects of the pension insurance system. The essential characteristics of pension insurance are presented, which are supplemented by clarification of basic categories such as pensions, pension products, the pension plan, pension scheme, pension fund with an emphasis on capital pension funds. It is focused on considering the issues of the financial organization, the

different types of pension payments, the elements of the pension system.

In *the second section* of the textbook, the main points in the development of the pension insurance system in Bulgaria are presented. The management of the pension insurance system is presented by clarifying the functions and responsibilities of the structures implementing the management of the mandatory state pension insurance and the capital component - the additional pension insurance in the second and third pillars.
