2. Relevance of the topic

The relevance of the dissertation research results from the dynamic changes in the economic and information environment. The significance of the research is found in the proposed scientifically based solutions for measuring innovative models to support early childhood development as an investment in the future of generations. Its relevance comes from the possibility of partnerships of institutions related to social work. Thus, the emergence and realization of such a development deserves support, as the efforts of Ekaterina Uzhikanova are aimed at supporting the process described above, and the results could optimize it to a high degree at any moment.

3. Knowledge of the problem

Significant for the presented work is the extensive use of documentary sources to confirm or refute the hypotheses. The doctoral candidate has an excellent knowledge of the state of the problem under development. A critical assessment of the state of processes related to current practices of social work in support of early childhood development is noteworthy. A set of approaches and analytical tools for assessment, analysis and forecasting such as documentary method, survey method, qualitative analysis and statistical methods of primary information processing are used. Ekaterina Uzhikanova has applied methodology and developed a methodology adequate to the researched issues.

4. Research methodology

The chosen research methodology allows to achieve the set goals of the dissertation and to obtain adequate answers to the set questions and tasks, it is relevant to the object of the study and the hypotheses. The research methods correspond to the objectives of the dissertation.

5. Description and evaluation of the thesis and contributions

Ekaterina Uzhikanova has realized the analysis of her dissertation in 161 pages with an introduction, three chapters, summary, conclusions, and recommendations for application in practice. The list of cited literature develops into 105 titles, 81 of which are in Cyrillic and 24 in Latin. Thus, the study is very well measured in the scientific context of the research of our and foreign authors. The achieved results are illustrated through 41 figures, thus achieving a broad deployment of the solution of the problems. The problem, although studied over the years, remains relevant due to the dynamics of public attitudes. The chapters of the dissertation are proportionate to each other, possess completeness and are relevant to the stated aims and objectives.

6. Assessment of publications and personal contribution of the PhD student

The publications mentioned in the review list are authored. The articles have been published in refereed scientific journals. The results achieved in the dissertation have found application in the system of social activities and have been used in projects.

7. Abstract

The submitted abstract complies with the requirements and reflects the main theses, conclusions and scientific achievements of the dissertation.

8. Recommendations for future research of the dissertation contributions and results

I recommend Ekaterina Georgieva Uzhikanova to maintain and expand her expertise in social work and practice.
