In the competition for the academic position of Professor, announced in the State Gazette, issue no. 31 of April 11, 2025, and on the website of the Paisiy Hilendarski University of Plovdiv, for the needs of the Department of Bulgarian Literature and Literary Theory at the Faculty of Philology, the applicant is Elena Slavova Getova from the Paisiy Hilendarski University of Plovdiv.

3. General characteristics of the candidate's scientific activity

In connection with her participation in the competition for the academic position of Professor, Assoc. Prof. Elena Getova has submitted one monograph and 20 scientific articles, of which 2 in refereed scientific publications, for evaluation. The materials submitted by the candidate for participation in the competition meet the requirements for scientific publications of the article type. The study "Petko Slaveykov's Journalistic XIX Century" in its subject matter, methodology and structure meets the requirement for a monographic study.

The monograph "Petko Slaveykov's Journalistic XIX Century", published in a book, is an attempt to add new touches to the journalistic and publicistic activity of the prominent Bulgarian Revivalist writer, poet and man of letters Petko R. Slaveykov. The study contains an introduction and three chapters. The first chapter "The Century, Europe, Journalism" aims to set the sociocultural context of the work, the presence and importance of journalism in it. The notion of the concept of "century" is discussed, both in theoretical terms, with all the relativity of this concept, and in the specifics of the Bulgarian journalistic view of this concept. The reader's gaze is successfully directed to the French press, related to this concept, and the Bulgarian replica in the edition of M. Balabanov – the newspaper, entitled "Vek" ("Century"). The Bulgarian 19th century is seen through the prism of Slaveykov's journalism, outlining the priorities for the Bulgarian

people, which, although they coincide in particular (the woman question, fashion, the schools), still have a specific character, related to the political dependence of our people and its economic backwardness. At the end of this chapter, the researcher attempts to summarize Petko Slaveykov's vision of the 19th century and quite naturally comes to the conclusion that it is difficult to speak of any cohesive concept held by our National Revival writer regarding the "century". Something entirely acceptable in view of his operational inscription in the dynamics of the rapidly changing socio-cultural environment.

The second chapter of the monograph is dedicated to the newspaper "Shutosh", several thematic accents are placed in the writing of the newspaper. The first of them is related to the selection of translated materials for the newspaper from the foreign press. The materials selected are mostly relevant to Bulgarian reality, but are also amenable to ironic or parodic transformation. Attention is paid to the thematic preferences of the translators – fashion, political hierarchy, and the function of translation to become a cultural transfer between two cultures is also noted. The third emphasis in this chapter is on the polemics related to the history of the newspaper, its Greek origin, and the difficulties of publishing. The study focuses on one of the main journalistic techniques, called "transfiguration" - the play between symbolic figures (headlines, recurring characters and motifs), something that I would call the intimation of the media environment, including the inclusion and cultivation of its own readership. This chapter also devotes space to journalistic personalities - most of all, attention is focused on the publisher Teodor Kasap (Theodoros Kasapis). Although standing as a private problem, the fate of this publisher also illustrates the model of cultural diffusion (in this case, French culture) here in the Balkans. At the end of this chapter, some genre transformations and experiments in journalism of that era are examined, the role of correspondence, prayers, parables, dream interpretations, interpretations, creating opportunities for satirical and ironic deformations of certain social images and phenomena. Attention is also paid to the possibilities of humorous publications for personal self-deprecation.

The third chapter "...and other journalistic territories" draws attention to other manifestations of the journalistic 19th century, related to one degree or another to the figure of P. R. Slaveykov. It follows the cultural and political dialogues between him and representative figures of the Bulgarian Revival, such as Marko Balabanov and Lyuben Karavelov, who were representative of the 1870s. They trace cultural behavioral patterns, also setting some cultural stereotypes of the era. For example, Karavelov-Botev's writing about Marko Balabanov leaves its

mark on Slaveykov's introduction of his image in periodicals. The important problem of the function of journalistic stereotypes for understanding a given era is touched upon. Another thematic core in this chapter is related to the literary and journalistic sanctions in Petko Slaveykov's journalistic practice. His activity as a journalist translating from the foreign press, but also evaluating the translated material, is traced. Specifically, the linguistic models for characterizing foreign peoples and ethnicities, but also linguistic models of national consciousness, are examined, in addition to Slaveykov and in Rakovski, Karavelov, Botev. According to the researcher, the following features of Slaveykov's journalistic stylistics should be noted: "verboseness, multitheme, polyvalence of statements, images branching into many meanings". At the end of the chapter, a place is dedicated to Petko Slaveykov's political project in his journalism from 1871-72. Two texts from 1881 and 1883 (namely the poem "Homeland" and the brochure "My Last Visit to Sofia") are compared with earlier journal publications, generating motifs and images – autoreminiscences, auto-citations of the later texts. National geography as a political project of the newspaper "Makedoniya" is projected onto the poem "Homeland". There is probably reason in such an observation, but one must also take into account the literary context in which the poem appears, and especially Vazov's patriotic poetry. This chapter also adds touches to the problem of "cultural enlighteners – revolutionaries" in Bulgarian literary scholarship. The researcher focuses on Karavelov's feuilletons, in which Slaveykov appears as a character. Attention is drawn to the feuilleton travesty of Slaveykov's image, mainly due to differences in the political views of the two revivalists.

4. Assessment of the candidate's personal contribution.

If I were to summarize the contributions in the scientific materials submitted for the competition, I would point out the following:

1. The understanding of the category "time", the concepts "century" (and more specifically the 19th century) and "literary year" based on journalistic publications, poetic works from the second half of the 19th century. The very entry of these concepts and categories into the vocabulary of the Bulgarian Renaissance writers and literary figures is a sign of a new type of attitude towards time, different from that of the Medieval and the Folklore man.

3. The monographic study, as well as some of the presented articles, add new touches to the image of Petko Slaveykov, especially as a journalist and publicist. The journalistic dialogues in the press between Slaveykov and M. Balabanov, L. Karavelov deserve special attention, giving a different perspective on him, but also revealing the literary mores of that time.
