1. General Presentation of the Procedure and the Doctoral Candidate

The research methodology employed by Vladimir Bonov Slavenski has enabled him to fulfill the research tasks and achieve the set objectives.

5. Characteristics and Evaluation of the Dissertation and its Contributions

The dissertation comprises 277 standard pages. Its structure includes an introduction, three chapters, a conclusion, a bibliography, and appendices.

The Introduction presents the relevance, research problem, main goal, object, subject, primary tasks, hypothesis, limitations, and methodology.

Chapter One, titled "Negotiations as Part of the Theory of International Relations," outlines the main theories regarding international relations, foreign policy, and diplomacy.

Chapter Two, "Bulgaria, the Balkans, and Macedonia at the Beginning of the 21st Century," examines the relations between the Republic of Bulgaria and the Republic of North Macedonia leading up to the 2017 Treaty.

Chapter Three is titled "The Treaty of August 1, 2017" and presents the methodology and results of the empirical study. The scientific contributions identified by Vladimir Bonov Slavenski are well-founded and can be accepted.

6. Assessment of Publications and Personal Contribution

The dissertation and the four submitted publications meet the regulatory and scientific requirements, demonstrating the candidate's ability to develop and defend scientific theses.

- 8. Recommendations for Future Use of Results
